Have received four resumes to date for the position of Financial Secretary and three resumes for the position of Sgt-at-Arms. Received one resume for Firefighter of the Year Committee. Thanked Anthony Sullo for his two years as Southern New York VFA President. He did an outstanding job as President.

FASNY Report by FASNY 2nd Vice President Eugene Perry

- Happy New Year form FASNY Officers, Board of Directors and Board of Trustees
- Thank you all for your support for me election as 2nd Vice President.
- All Full Company Membership Renewals have been sent out. Individual Membership Renewals will be going out shortly. Harrison Brauer no longer works for FASNY.
- FASNY Awards are all on-line applications, deadline is March 15th. If you know a deserving candidate be sure to fill out the application. FASNY awards 25 \$1,500 Scholarships to recognize High School Seniors entering college. The online application is on the FASNY website. Deadline is March 15th.
- Recruit NY weekend is April 24-25. FASNY is building a tutorial on how to conduct a virtual event or Traditional Open House. We encourage all Departments to sign up at recruitny.org and participate. The website has all the material you need to have a successful event. Last year over 800 Departments statewide signed up. We are planning virtual Press Conferences across the State prior to the weekend.
- In November, the Governor signed into law establishing a Recruitment and Retention Task For. This group will examine different Training and deliver methods. Establish Firefighter 1 training into High Schools, community Colleges and BOCES. Tax incentive and other volunteer benefits and recommendations on these or new programs, Analysis of current recruitment and retention programs being utilized in other states and recommendations as to the adoption of similar programs in New York; and Identification of recruitment incentives to assist in recruitment of volunteer firefighters from under-represented and at-risk populations. The task force must submit a report to the Governor by April 2022. FASNY along with the State Chiefs, Districts and Fire Coordinators each have a seat on the Task Force. The FASNY Presidents are in the process of vetting names for our seat as well as making recommendations for other seats at this time.
- FASNY has launched a Recruitment Social Media Campaign. Go to your Social Media Platforms, search “FASNY Firefighter Recruitment” and share it.
- Upcoming virtual FASNY training, ON February 22nd at 7pm the topic will be Professional Development for the Volunteer Fire Officer presented by Tom Merrill, a 38year Fire Department Veteran who serves with the Snyder Fire Department, which is in Amherst NY. On Sunday, March 21st also at 7pm, the topic will be “UL Attack Study” Modern Tactics presented by Battalion Chief Jerry Knapp, a 40-year veteran Firefighter/EMT with the West Haverstraw, NY and Fire Department training officer at the Rockland County Fire Training Center. FASNY will continue to offer these Training webinars due to the reduction of in person training as we continue our mission to inform and educate the Volunteer Fire Service. The course synopsis as well as the link for those webinars are on FASNY’s website under the Training Tab.
- Looking towards the fall (depending on COVID) FASNY will be hosting an in-person Training Weekend at the State Preparedness Training Center in Oriskany, NY September 24-26, courses and more information as the dates get closer.
- FASNY will also officer in person (Again Depending on COVID) ESIP Training “Preparing for the Future When You are Stuck in the Past” with David Denniston, Region 4 Director of the Association of Fire Districts of the State Of New York at the West Babylon Fire Department on Saturday, May 1st. Registration for this course will be \$15 for FASNY Members/ \$20 for Non-Members.

- Again, I would like to thank you for your support as 2nd Vice President. I've already learned a lot since my election in October, with more to come.

Home trustee -President Jerry Owenburg – Happy New Year to all. They have 68 brothers and sisters. One member tested positive but no symptoms a few staff members. No visitors at this time. Accepting applications for county days but will depend on COVID-19. All members eligible have received both shots. Part of staff got both shots; rest of staff have first and will get second the end of February. Staff still tested twice a week. If someone tests positive, they then have to test the residents again. They are having a tough time. Dudley Philhauser 97 years old from Stony Brook passed away at the Home. We have two left from Suffolk County. They are working on 5 applications and just sent another 7 out. If you know of anyone let him or Peter know.

Suffolk County Chiefs – no one present.

Suffolk County Ladies – President Marybeth Asbell wished all a Happy New year – Stay safe. She misses everyone – The ladies are zooming and have two fundraisers they are working on a 100 club and a new lottery scratch off. We made a video for the Firemen's Home – Lori and Jean provided pictures and Lizz Christensen put it together for them. Great to see everyone – stay safe and God Bless.

Long Island Day at the Firemen's Home – Jerry – have date – have application in but will be dependent on COVID. It is the third Sunday in September.

Parade and Drill Officials – Suffolk met in Lindenhurst – Eugene was elected Treasurer and they are planning their year. If you wish to become a drill or parade official please contact them, they are both in need of officials.

FRES – Bob McConville – no report - they meet tomorrow on Zoom. They do get updates from the Commissioner.

Radios – Anthony Sullo had to be excused – told Vinny he had nothing.

VEEB Board – Gary Schaum – not on.

Fire Police – been zooming – no Montour falls in March will be up in Deerfield and the Convention is May 13, 14,15 in Niagara. A tentative April 9 & 10 Fire Police meeting statewide in Hagerman, dependent on Governor.

Legislation – Jerry Owenburg – he has nothing unless Vinny does.

Score card is out – had Legislative meeting in November in Troy and United concern meeting was held on zoom. Vinny read us the scorecard:

Issues of United Concerns:

- Chapter Amendments to Cancer Coverage Verification Requirements was signed by the Governor 12/23/19.
- Relates to the regulations of chemicals in upholstered furniture, mattresses, and electronic enclosures – 2020: referred to Environmental Conservation Committee by the Senate and pending introduction to the Assembly.

- Prohibits the use of chemical flame retardants on residential upholstered furniture – Senate Status – 2019: Referred to the Rules Committee – 2020 Referred to Environmental Conservation Committee and in the Assembly in 2019 was on third reading on the calendar and 2020 on third reading on the calendar.
- Endangering the welfare of a first responder by making illegal modifications – 2019 Referred to Codes Committee and 2020 Referred to Codes Committee by both the Senate and the Assembly.
- VFBL/VAWQBL Temporary Total Disability Increase Senate – 2019 passed senate and in 2020 Referred to Local Gov. Committee and in the Assembly for 2019 & 2020 referred to Local Gov. Committee.
- 5-Year Extension of Heart VFBL/5-year extension of Lung VFBL – signed by Governor as part of FY2021 Final Budget 4/3/20.
- The “Fair Play” cost recovery for fire department ambulance service – Passed the Senate in 2019 and in 2020 passed the senate on 7/21/20. In the Assembly in 2019 it died and 2020 it was referred to Local Gov. Committees.
- Recruitment and Retention Task Force – was delivered to the Governor 10/30/20.
- Legislation for the creation of career and technical education pathways in the areas of Fire Protection and EMS – Pending Introduction to the Senate and Assembly.

Other FASNY Scorecard Items:

- Reducing the use of PFAS chemicals in firefighting activities – Chapter Amendment – Signed by the Governor on 4/29/20.
- Relates to the determination of points for LOSAP during a state disaster emergency - Signed by the Governor 6/17/20.
- Modernizing School Fire Inspections – Signed by the Governor 12/16/19
- Increasing maximum contribution for certain service award program – Signed by Governor 11/8/19.
- Expand length of Time Between Recertification – Pending Introduction into the Senate and the Assembly.

President thanked Vinny for his report.

Firefighter of the Year – Past President Roger Putnam – Been in contact with George at Awards & Gifts and is in the process of doing the 2020 plaques for North Patchogue FD> As stated before he is resigning from this position and hopes that someone will step up. He has been out of commission for about 8 months. He had an aortic aneurysm and thank god it was caught and he had surgery next day.

Bob Holly is retiring April 1st and he is the go between for Roger, he sends applications to Roger that are submitted for medal day. Gloria will forward applications as received to Roger until a replacement is found. President thanked Roger for his service and the time he has put in for many many years and wishes him good health. We are there for anything he may need.

President’s Report

VEEB

- There was a change to the Intro to Fire Officer prerequisite. The member will now only need Firefighter 1 and one year after completion of the Firefighter 1 course to enroll. This should help in making it easier for firefighters to get into that course.
- Work is underway on the taxpayer with the door and window replacement project, will be completed by March.
- Trench Rescue simulator construction is also underway, will also be completed by March.
- Edward Johnston was appointed Chief of the Fire Academy. Chief Holley is retiring in April.
- Deputy Chief position to be filled soon.
- Advertising in Fire News for Maintenance Mechanic position.

Trying to handle the pandemic the best they can and offering online classes.

Audit - Jerry Owenburg – was going to do this week but he got tied up – he will set up in near future.

EMS – Meryl was not present. Peter has not heard much other than PPE and using it on all calls, using minimal people on calls. John Fleischmann reported that Paul Marra has been appointed to EMS 1.
