S1515 / A2177A: This bill was introduced by the South Country Ambulance Chief Greg Miglino. The bill removes EMS from the limit on real property tax levies by local governments. The bill takes effect once signed by the Governor.

S31 / A34: The bill provides NYS Thruway shall issue permits for ambulances and fire vehicles for toll exemptions when engaged in emergency operations.

S7501 / A8086A: The bill directs counties in coordination with their regional emergency services councils, to develop and maintain comprehensive county emergency medical systems plans that provide for coordinated emergency medical systems within such counties.
