Fire Prevention - Don Bracciodieta

- As New Yorkers begin to prepare for colder weather and winter holidays, I want to share some sobering statistics with you all I share them as a reminder that fire & life safety education does NOT stop after Fire Prevention Week. It is a year-round commitment. I also share them with the hopes that, together, we can better inform each of our customers to prevent history from repeating itself. In 2021, New York last 151 people in 126 fire related incidents across our state. November 2021 had the highest number of fire-related deaths, with 24 people dying from fire-related incidents, 4 of which had two or more fatalities. AS of today, New York has lost 129 people in 94 fire-related incidents across our state in 2022. WHERE IS THE OUTRAGE?!! Many of these deaths could have been prevented if some very simple steps were followed, not by response agencies, but by our customers!!! Those steps include: Do your best to prevent fire. Get early notification (SMOKE ALARMS!!!) when fires do occur and when notified of a fire, get out quickly and call 911!
- Lithium-ion Batteries: With recent increase in fires involving Lithium-ion batteries, some of them causing fatalities, it is more important than ever to share the information found at this link: https://www.nfpa.org/Public-Education/Fire-casues-and-risks/ebikes
